BACKGROUND...

FLINTSHIRE LOCAL VOLUNTARY COUNCIL

(FLVC) is the independent umbrella and support organisation for voluntary and community groups in Flintshire. It is one of 19 County Voluntary Councils (CVCs) in Wales and began operating in 1997. FLVC is a registered charity (1062644) and a limited company (3301204). It has up to 15 trustee directors drawn mainly from the local voluntary sector with 16 staff, part time and full time. Since 2008 FLVC has been based at CORLAN on Mold Business Park. FLVC has over 220 members and draws its funding from a variety of sources, including Welsh Government, Flintshire County Council, Families First and Betsi Cadwaladr University Health Board (BCUHB).

We are part of the Third Sector Support Wales infrastructure funded by Welsh Government. Our shared goal is to enable the third sector and volunteers across Wales to contribute fully to individual and community well-being, now and for the future.

Third Sector Support Wales is a network of support organisations for the whole of the third sector in Wales. It consists of the 19 local and regional support bodies across Wales, the County Voluntary Councils (CVCs) and the national support body, Wales Council for Voluntary Action (WCVA). We work with citizens, volunteers and third sector groups to identify and address what matters to them. To achieve our shared goal we collaborate with other key partners across the third sector, the public sector, business, research and funders.



Understanding the third sector and its contribution to our communities and people's lives provides my organisation with a strong foundation for partnership working and improving services.

What Did We Achieve?

Our Volunteer Centre played a key role in Flintshire's Covid 19 Response and Recovery. We enabled over 200 Volunteers to be deployed throughout Flintshire during the pandemic to support individuals, organisations and the community via distribution of PPE, Prescription/Food collection & delivery, nonclinical support for the Vaccine roll out to support GP surgeries and 1-2-1 befriending opportunities for vulnerable and isolated individuals

5 Volunteer Network Forums were held during the year attended by a total of 56 participants

GOOD GOVERNANCE

The overall goal of TSSW's work on good governance is for those involved in running third sector organisations effectively lead their organisations and to maintain high standards of governance.

Our outcomes are for those involved in running third sector organisations to:

- access information, advice and support on good governance;
- have increased confidence in leading their organisations;
- have improved ability to recruit and retain skilled trustees;
- have increased skills to lead their organisations.



What Did We Achieve?



Our website received over 28,000 visitors and information was disseminated to organisations via e-groups

We have worked with Welsh Government and local authority colleagues to support organisations and community venues with their policy and practice for 'reopening' as Covid 19 restrictions eased

SUSTAINABLE FUNDING

Our Funding Support service aims to help

- Third sector organisations to effectively secure and generate the resources they need to survive and grow
- Third sector organisations to be resilient and have the skills, knowledge and capacity to sustain their organisations



What Did We Achieve?



We supported 124 community and voluntary organisations to access in excess of £607,900.00 from a number of funding sources

A digital Meet the Funder event was held with the National Lottery Community Fund, and a number of digital appointments were made for 1-2-1 support.





Having worked in partnership with FLVC over this pandemic I have realised how much support they do actually give to other voluntary organisations and groups within the county. It is extremely effective and very well organised.



We administered 7 grant funds (a total of 97 individual grants awarded):

- FCC Flintshire Community chest, awarded 21 grants totalling £14,581.63
- Early Help Transformation Fund, awarded 15 grants totalling £131,474
- Voluntary Services Emergency Fund awarded 31 grants totalling £26,591
- Comic Relief Covid Emergency Fund, awarded 14 grants totalling £27,475
- Flintshire Befriending Fund (Friend in Need) awarded 6 grants totalling £12,500
- Flintshire Learning Disability Fund awarded 5 grants totalling £5,000
- Youth Led Grants, awarded 5 grants totalling £5,000

ENGAGEMENT and INFLUENCING



As a member of Third Sector Support Wales we work to ensure that

- Public bodies recognise the value and current and potential contribution of Third Sector organisations.
- Third Sector organisations play an active role in engaging and working with people and communities, including seldom heard groups;
- Third Sector organisations have the skills and capacity to effectively influence and shape policy at all levels;
- Third Sector organisations meaningfully engage with each other and in turn with public bodies in policy development and service coproduction;
- The voices of individuals and groups inform and influence policy development, service planning and delivery;



FLVC have been a critical partner in the COVID-19 response for the council and have worked with Social Services on the strategic response to the pandemic.

What did we achieve

- We have met regularly with Statutory and Third Sector partners as part of the local, regional and national Covid 19 Response and Recovery Planning
- We have worked with partners in co-ordinating Third Sector links to the Test trace Protect Service
- We have worked with Flintshire County Council and Betsi Cadwaladr University Health Board to influence procurement practice for a multi-agency approach to Public Services
- We have led on work as part of the joint Flintshire and Wrexham Public Services Board 'Community Resilience' Workstreams
- We have worked with TSSW partners on the national Learning and Development Strategy, Impact workstream and Safeguarding Community of Practice
- We link to Regional Strategic Planning meetings regarding Workforce Development and Adult Community Learning
- We have worked with a national working group exploring options for Volunteering in Health and Social Care, and have developed a Flintshire-based pilot programme to support the care sector

Expanded our Social Prescribing Team from 2 to 5 members of staff

Provided Third Sector training to Test Trace and Protect Staff





Co-ordinated a Third Sector response to contribute to work of the Local Implementation Team (Mental Health)





Developed a bespoke package of volunteer support to help within Social Care settings

In collaboration with AVOW in Wrexham, we host Health and Social Care Network meetings, attended by up to 50 participants. Bringing together Third and Statutory sector service providers to learn, share and consult on key Multi-agency strategies,




